Peer on Peer Abuse Worries:

Newton – le Willows Primary School recognises that during the closure a revised process may be required for managing any report of such abuse and supporting victims. The school will listen and work with the young person, parents/carers and any multi- agency partner required to ensure the safety and security of that young person. Concerns and actions must be recorded on CPOMs and appropriate referrals made.

Encourage your child to be in the same room as you when using the internet. If you have chosen to supplement your child's learning from on-line companies or individual tutors, please ensure these are reputable organisations/individuals. We strongly suggest if using these organisations/individuals, that you request evidence that they are safe and can be trusted to have access to children.
